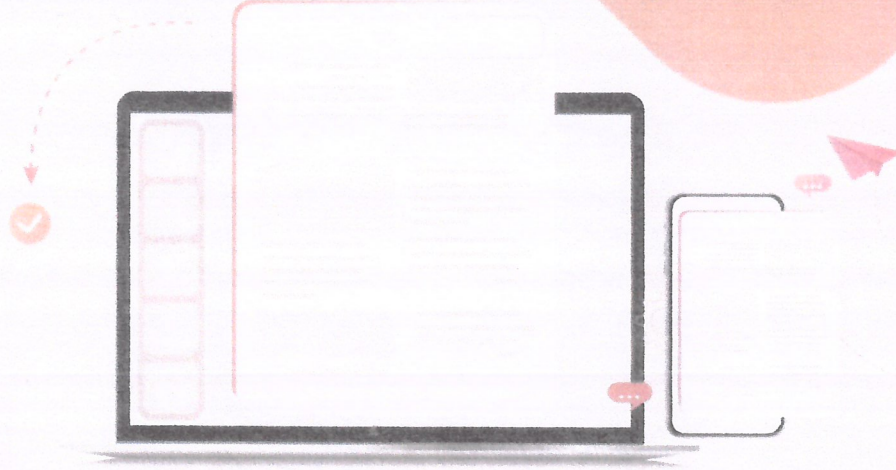



The PG Department of Commerce organized a workshop on E-Filing process of GST - A practical outlook on Wednesday, 22 February 2023 at 1:30 p.m. from the College Auditorium. The programme was led by Mr. Vinayaraja M, a renowned GST consultant based in Thalassery, Kannur. The audience represented the students of 3rd year B. Com CA, Co-operation and final year PG students. The faculties of Commerce Department graced the occasion with their presence. The session began with a welcome speech delivered by Ms. Lakshmi V R, Assistant Professor in commerce.

The facilitator elucidated the basics of GST and elaborated on minute details that needs to be given immense attention while filing Tax returns. This was followed by a live demonstration of ascertainment of GST and its implications. At the end of the session, the audience were given an opportunity to interact with the guest of honour for clarification of doubts arising on account of GST and its provisions. The students gained an in depth understanding of the theoretical and practical aspects of Goods & Services Tax. They enjoyed the workshop and complimented the organizers for arranging a programme that they would benefit from.
